

IRAN STEPS Survey 2009

Fact Sheet 1388

This STEPS survey of chronic disease risk factors in I ran was carried out from 5/2009 to 6/2009 as the 5^{th} round concluding Step 1 and Step 2; Socio demographic and behavioral information was collected in Step 1. Physical measurements such as height, weight and blood pressure were collected in Step 2. biochemical measurements were not collected in this round.

The STEPS survey in I ran was a population-based survey of adults aged 15-64. A cluster sample design was used to produce representative data for that age range in I ran. A total of 30000 adults participated in the I ran STEPS survey.
